#### MODE OF MEETING

The 27<sup>th</sup> AGM of the Company will be conducted on a fully virtual basis through live streaming and online meeting platform at TIIH Online provided by Tricor Investor & Issuing House Services Sdn Bhd ("Tricor") in Malaysia via Remote Participation and Electronic Voting ("RPV") facilities.

### SHAREHOLDERS' PARTICIPATION AT THE 27TH AGM VIA RPV

- Shareholders are to attend, speak (in the form of real time submission of typed texts) and vote (collectively, "participate") remotely at the 27<sup>th</sup> AGM using the RPV provided by Tricor.
- The RPV are available on Tricor's TIIH Online website at <a href="https://tiih.online">https://tiih.online</a>.
- We strongly encourage you to participate the 27<sup>th</sup> AGM via the RPV. You may also consider appointing the Chairman of the meeting as your proxy to attend and vote on your behalf at the 27<sup>th</sup> AGM.
- Kindly refer to Procedures for RPV as set out below for the requirements and procedures.

### NOTE TO USERS OF THE RPV:-

- (i) Should your registration for RPV be approved, we will make available to you the rights to join the live stream meeting and to vote remotely. Your login to TIIH Online on the day of meeting will indicate your presence at the virtual meeting.
- (ii) The quality of your connection to the live broadcast is dependent on the bandwidth and stability of the internet at your location and the device you use.

### ENTITLEMENT TO PARTICIPATE AND APPOINTMENT OF PROXY OR ATTORNEY OR CORPORATE REPRESENTATIVE

- Only members whose names appear on the Record of Depositors ("ROD") as at 18 May 2023 shall be entitled to attend, speak (in the form of real time submission of typed texts) and vote in the 27<sup>th</sup> AGM or appoint a proxy(ies)/ corporate representative(s)/attorney(s) and/or the Chairman of the Meeting to attend and vote on his/her behalf.
- In view that the 27<sup>th</sup> AGM will be conducted on a fully virtual basis, a member can appoint the Chairman of the Meeting as his/her proxy and indicate the voting instruction in the Form of Proxy.
- If you wish to participate in the 27<sup>th</sup> AGM yourself, please do not submit any Form of Proxy for the 27<sup>th</sup> AGM. You will not be allowed to participate in the 27<sup>th</sup> AGM together with a proxy appointed by you.
- Accordingly, Form of Proxy and/or documents relating to the appointment of proxy/corporate representative/attorney for the 27<sup>th</sup> AGM whether in hard copy or by electronic means shall be deposited or submitted in the following manner not later than Wednesday, 24 May 2023 at 10.00 a.m.:-

### II. Steps for Corporation or Institutional Shareholders

### Register as a User with TIIH Online

- Access TIIH Online at https://tiih.online.
- Under e-Services, the authorised or nominated representative of the corporation or institutional shareholder selects "Create Account by Representative of Corporate Holder".
- Complete the registration form and upload the required documents.
- Registration will be verified, and you will be notified by email within one (1) to two (2) working days.
- Proceed to activate your account with the temporary password given in the email and re-set your own password.

Note: The representative of a corporation or institutional shareholder must register as a user in accordance with the above steps before he/she can subscribe to this corporate holder electronic proxy submission. Please contact our Share Registrar, Tricor, if you need clarifications on the user registration.

# Proceed with submission of Form of Proxy

- Login to TIIH Online at https://tiih.online.
- Select the corporate exercise name: "HEXCARE 27TH AGM Submission of Proxy Form"
- Agree to the Terms & Conditions and Declaration.
- Proceed to download the file format for "Submission of Proxy Form" in accordance with the Guidance Note set therein.
- Prepare the file for the appointment of proxies by inserting the required data.
- Proceed to upload the duly completed proxy appointment file.
- Select "Submit" to complete your submission.
- Print the confirmation report of your submission for your record.

#### **VOTING AT MEETING**

- The voting at the 27<sup>th</sup> AGM will be conducted on a poll pursuant to Paragraph 8.29A of the Main Market Listing Requirements of Bursa Malaysia Securities Berhad ("Bursa Malaysia"). The Company has appointed Tricor to conduct the poll voting and Asia Securities Sdn. Bhd. as Independent Scrutineers to verify the poll results.
- Shareholders or proxy(ies) or corporate representative(s) or attorney(s) can proceed to vote on the resolutions before the end of the voting session which will be announced by the Chairman of the Meeting and submit your votes at any time from the commencement of the 27<sup>th</sup> AGM at 10.00 a.m. Kindly refer to "Procedures for RPV" provided above for guidance on how to vote remotely via TIIH Online website at <a href="https://tiih.online">https://tiih.online</a>.
- Upon completion of the voting session for the 27<sup>th</sup> AGM, the Scrutineers will verify the poll results followed by the Chairman's declaration whether the resolutions are duly passed.

### **RESULTS OF THE VOTING**

The resolutions proposed at the 27<sup>th</sup> AGM and the results of the voting will be announced at the 27<sup>th</sup> AGM and subsequently via an announcement made by the Company through Bursa Malaysia at <a href="https://www.bursamalaysia.com">www.bursamalaysia.com</a>.
